Engagement

The Model agrees with the Photographer to the Consent, the Assignment above in return for:

750/1.000/1.250 CZK pr hour effective from start of the shoot. (Cash at the end of the shoot)
 Depending on level of experience. The model will also receive 10 photos from the photographer for own non-commercial use on portfolios etc within a Month of the shooting. This delivery the whole obligation of the photographer towards the model. Model will receive 200 CZK for transport. Lunch breaks etc is on own costs however the photographer will pay for food and drinks.

The model *will credit* the photographer for the photos on all media (Instagram, Facebook, private webpages etc.) (Tag persons) and cannot make substantial changes to the photos without the consent of the photographer as mentioned below.

Special conditions – sponsored clothes.

Some clothes might be borrowed from commercial companies. The clothes belong to the companies and must be returned upon use. (*Currently not relevant*) Model must credit the different clothes brands in case.

Scope of release

Model agrees that, while she may use the Photos for purposes related to the promotion of Model's modelling business, including, but not limited to: advertising, portfolios, composite cards, exhibitions, contests, and promotional web sites, **Model will not sell or otherwise transfer publication rights** to any of the Photos without Photographer's prior consent.

Likewise, Photographer agrees that while he may use the Photos for purposes related to the promotion of Photographer's photography business, including, but not limited to: advertising, portfolios, composite cards, exhibitions, contests, and promotional web sites, **Photographer will not sell or otherwise transfer publication rights** to any of the Photos except with Model's prior consent.

If the shoot has a sponsor the sponsor may use the pictures for normal commercial use limited to his/her's own brand. The sponsor will when possibly credit the model.

Model understands that Photographer has the moral right to be identified as the author of the Photos when copies of the Photos are presented to the public, and shall communicate this understanding to

publishers, designers and other third parties that act on Model's behalf to create presentation material using the Photos.

Model agrees that the Photos shall not be cropped, altered or distorted in any way when they are used to promote Model's modelling business. Any watermark and copyright notice that appear as part of a Photo must be left intact.

Model releases and agrees to hold Photographer and/or his heirs, licensees or assigns, harmless from any claim or liability in connection with the publication or use of these images in any manner or form whatsoever under this release form, unless it can be clearly shown that the foregoing was maliciously caused, and produced, and published solely for the purpose of subjecting Model to conspicuous ridicule, scandal, reproach, scorn, and indignity.

Model does not agree to alterations being made to the photographs that would make the images appear to be pornographic, defamatory, or illegal.
